American Budgerigar Society Judges and Exhibitors Notes

Appendix to Judges and Exhibitors Notes

Changes will be made to reflect any changes (or lack of change) made at the 2004 All American.

All Varieties:

The World Budgerigar Organization (WBO) Colour Standards represent the ideal for each variety, not necessarily reality. Few budgerigars will conform to these standards. Unless guidance is given to penalize a specific fault, penalize deviations from the ideal standard according to the degree of deviation. An example would be a black tail feather or patchy body color on an Australian Pied. These would be deviations from the standard, there is not a specific requirement to penalize these deviations; the judge must weigh a deviation with the over all quality of the bird and the other birds it is competing against. Use the WBO Point Scale as a guide when assessing deviations from the standard.

Yellowface Albino:

Current ABS guidance is: Yellowface Albino is to be shown in the appropriate Albino class in the Red Eye Section. Yellowface should not be considered a fault; only <u>BLUE suffusion</u> MUST be penalized (WBO 2001 Colour Standards & 1998 BS Colour Standards). The yellow wash will vary according to the type of Yellowface present. (Type I, Type II, or Australian Yellowface).

Yellowface Composites:

Current ABS guidance is: Yellowface is to be ignored for the following varieties - All Rare Division varieties, Albino, Australian Pied, and Spangle. These varieties are to be shown as if Yellowface was not present. There is no guidance to penalize these varieties for the presence of Yellowface. They will not compete for "Best Yellowface" awards (56/1989 "A bird shall only be considered for a single variety award.").

Australian Pied:

The Australian Pied may be combined visibly with all other varieties (except Ino and Dark Eyed Clear). When exhibited, Australian Pied combined with other variety(ies) must conform to the standard for Australian Pied with the allowance for the other variety(ies) characteristics. Example: Australian Pied Cinnamon must still meet the standard for Australian Pied with the allowance that body color will be 50% of normal

body color; Spots, Markings, and flights will be cinnamon brown; and feet and legs will be pinkish grey per the standard for Cinnamon. Exhibit Australian Pied composites according to current ABS Composite Variety guidance.

Spangle:

The Spangle may be combined visibly with all other varieties (except Ino and Dark Eyed Clear). When exhibited, Spangle combined with other variety(ies) must conform to the standard For Spangle with the allowance for the other variety(ies) characteristics. Example: Spangle Cinnamon must still meet the standard for Spangle with the allowance that body color will be 50% of normal body color; Spots, Markings, and flights will be cinnamon brown; and feet and legs will be pinkish grey per the standard for Cinnamon. Exhibit Spangle composites according to current ABS Composite Variety guidance.

All Rare Division Varieties:

The Rare Division is unique to the ABS and was introduced to promote and showcase the development of "Rare" Varieties. To insure maximum eligibility to compete for Best of Variety awards; Cinnamon, Opaline, Cinnamon Opaline, Yellowface, and any Dark Factors, combined with the "Rare" variety will be ignored for variety purposes unless specifically noted. Example 1: Clearwing combined with Opaline will still compete in the Clearwing section of the Rare Division. Example 2: Red Eye Lacewing White combined with Yellowface will still compete in the Red Eye Lacewing section of the Rare Division.

Clearwing:

The following is the WBO standard for Clearwing tail color - "Neutral with ground or body color suffusion". Do not wrongly interpret this as a clear "yellow or white" tail. "Neutral" is a color also described as a very light, tanish – gray. The description is not of a Spangle X Clearwing composite, which would have an all yellow or white tail.

Clearflight & Dutch Pied:

The WBO standard for both these varieties states: Flights - "buttercup yellow" or "white" (green series or blue series) vice "seven buttercup yellow" or "seven white" from the 1998 BS colour standard. The meaning is the same, ALL flights *should* be clear yellow or white; deviations should be penalized accordingly.
