To clarify how points are earned during a lapse in ABS membership the

following is added as the last sentence to Rule #5: Any EOY points earned at shows during a lapse of membership will not be counted towards the EOY Award calculations. Motion 13 - ABS charge an additional fee to ABS members who exhibit non-ABS banded birds. Such winning, non-ABS banded, birds would be eligible for ABS awards. A card would be issued by the ABS Secretary verifying payment (suggested to be 50% of the cost of 100 bands) renewable yearly. Suggest this fee be \$50. the cost of an ABS Plaque. Motion made by Larry Moore **Failed** for lack of a second

Motion 14 - That BAA bands be accepted by ABS for points, advancement and plaques as long as the BAA exhibitors are registered with ABS. **Failed** for lack of motion.

Motion 15 - Any non-ABS closed and traceable banded bird be eligible for ABS awards and points by being charged a separate entry fee of \$2.00. Once collected, the additional fee will be sent to ABS to help cover costs for ABS. Motion 27 – Presented by Qualifying Committee: Under "II. Qualifications Required of Applicant to the A.B.S. Judge's Panel" Change Rule "A" to state "A. The applicant must have bred and raised budgerigars for exhibition purposes for a minimum of seven (7) years."

"One Exemption be allowed, per Qualifying Committee approval."

Add a rule "III." To be called "Foreign Judge Applicants" and make current rule III, Rule IV.

Under "Foreign Judge Applicants" have the following rules.

A. Definition of a "Foreign Judge" a Budgerigar judge who resides outside the USA.

B. All Rules in Section II. "Qualifications Required of Applicants to the A.B.S. Judge's Panel" shall apply unless overridden by "Foreign Judge Rules".

C. Any foreign judge applying must submit proof of current or past status as a certified judge and submit a copy of rules from their society.

- D. Applicant will only need to be a member of ABS in good standing for three (3) years.
- E. Once being approved as a Trainee, he/she will not have to take training sessions, number (1) one and number (2) two.
- F. Any Judge Applicant can only serve on one USA panel.

Revisit **Motion 18** - The ABS should establish a standard method of Judging Juniors. This motion was **tabled** until after Judges Panel Meeting. The Judges Panel minutes state: "The Rares need to be judged first. Juniors need to follow with placement as the other divisions. An advisory item, the Juniors should not be moved to the Novice Division." Motion withdrawn by Holger Moeller and David Hyatt
