Motions from other Districts were considered and the following motions passed by other Districts were voted on:

 Motion to remove the Past President of ABS from serving on the Executive Committee of ABS and to instead have that seat on the Executive Committee filled by the Chairman of the Judges Panel.

In discussion, the sense of the meeting was against this change, and that there was no need to make a change to a system that had been in place for years, and that Past Presidents typically provide continuity and unique experience for the benefit of ABS.

Motion failed (0 for: 11 against; 0 abstentions).

2. Motion that the ABS Bulletin be published on schedule, no matter what, regardless of whether there was sufficient content

In discussion, there were views expressed both for and against this, but the sense of the meeting was mostly against this change. It was felt that the need for flexibility to allow some

delay to ensure a quality bulletin, outweighed publishing on schedule, regardless of adequate or sufficient content. Members felt that the Second Vice President should have support in the

role of ensuring adequate content for the bulletin.

Motion failed (4 for: 7 against; 0 abstentions).

The following Motions were made and voted on as District 10 motions:

3. That the ABS Second Vice President be authorized to establish a committee to support the

publication of the ABS Bulletin and see to it that timely input of material for publication is

provided to the editor.

4. That ABS reinstate Terry Travis to active status on the Judges Panel and remove his

suspension.

tolerance and forgiveness.

The meeting adjourned, there being no other business to conduct.
