Jack Vater, David Bluma – Passed Unanimous

No new business from members. Review of motions from other districts

Motion: ABS Editor with hold publishing of BAA shows until the BoD has reciprocal agreement with BAA to include the ABS shows in their bulletin.

Al Jakubowski, Ernie Scwarcz – Passed Unanimous

Discussion: ABS affiliation costs include that "advertisement." Was a reciprocal agreement made to include ABS shows in the BAA bulletin?

Novice Advancement rules: Bill Birney provided some context around advancement rules discussions: It is difficult for a novice to get the required number of wins at this stage due to the number of exhibitors declining. Russ Roberts indicated that advancement rules were designed to **not** force somebody to advance before they are ready, rather than to force people to move up. It was noted that any exhibitor can advance themselves when they feel ready, even without the wins.

Motion: ABS produce a directory with each member's contact information allowing members to <u>opt in</u> rather than opt out to comply with HIPAA requirements. The directory would be available for a fee (\$5.00), if requested by an ABS member. Emphasizing that members would be required to opt in.
