Motions for district 10:

would be awarded 10 points. Total the points, from all of the shows and at the end of the year the winner
would receive a certificate, awarded at the All American at the same time Exhibitor of the Year Awards
are presented. Reasoning: To promote more interest in exhibiting the varieties. Cost to ABS: minimum –
cost of certificates

M-Miles S-Travis Passed Unanimous.

 Reset the boundary for district 9 & 10 to move San Luis Obispo and Bakersfield to District 9. Reasoning: Existing ABS members live closer to the district 9 clubs and currently attend those meetings. Cost to ABS: None.

- Lower the number of birds to qualify a show to 85. Still also need 3 Champions and 25 champion birds. Reasoning: Shows are getting smaller and some shows are not sanctions with the current requirement of 100 bird minium. Cost to ABS: None M – Miles S – Travis Passed Unanimous
- To stimulate entries in the All American and regional shows I propose a 1.5 multiplier at a regional and a 2.0 multiplier at the All American for Exhibitor of the Year points. Reasoning: See motion itself. Cost to ABS: None.

M-Miles S-S. Merchey Passed Unanimous

- Motion to award the best young in show an additional 50% of the show points towards EOY. Reasoning: To promote and encourage exhibitor's entering young birds at a show. Cost to ABS: None. M- Travis S – Miles Passed Unanimous

Reasoning: Motions brought before the judge's panel are related directly to show/judging expectations. Currently, there is no credibility given to the results of those motions when they must be returned to the Exec. Committee and board for approval. Cost to ABS: None.
