- 13. Motion that ABS exhibitors may submit point from BAA show for points toward ABS exhibitor of the year as long as birds are ABS banded. (D11)Motion made by Paige Gover and Seconded by Larry Moore. Failed and had 1 to Abstain (Gover)

#### Motions from Judges Panel -

- 1, Motion to change the qualifications for becoming a judge
- A. Motion to change Article II Paragraph A to read "The applicant must have bred and raised budgerigars for exhibition purposes for a minimum period of five (5) years.
- B. To change Article II Paragraph B to read: The applicant must be a champion breeder and must have exhibited his/her birds in champion division of ABS patronage shows for a minimum of 36 months prior to filing application as a trainee. The month in which he/she exhibits the first time as a champion counts as the beginning of the 36 month period. In addition to this, he/she must have placed, as a champion, First, Second or Third Best in Show with three(3) different birds (bred by the trainee) at three(3) different shows with three(3)different ABS Panel Judges during the five(5) calendar years immediately prior to application to the panel. A maximum of two (2) wins per year may count. In order for these wins to count for the trainee, there must be a minimum of 100 birds entered in each of these shows. There must also be a minimum of three (3) champion exhibitors that exhibit a total of twenty-five (25) birds.

2. Motion to make the Judges' Panel more transparent. Nothing should be hidden from the A.B.S. General membership with the exception of health and financial issues. There should be less confidentiality and more openness. This could be done by changing Article E paragraph 12c to read: All complaints are to be of a confidential nature and not to be discussed by any A.B.S. Judge outside of the group considering the case until after all investigations, reviews, any appeals and final decision has been completed. As well as the last sentence in Article E paragraph 12f to read: Further communication of the final decision shall be authorized by the Judges' Panel Executive Committee.
