Roll Call- All present except Kevin Smith.

Motion Passed unanimously- "To update the committees on the Judge's Panel so that the committees have the correct number of members.

Motion passed unanimously to reduce the number of committee members on the Judge's Panel to three members.

Motion passed that each division of a show be judged in entirety by one judge. (No splitting of divisions when there are two or more judges.)

Motion passed that a judge must obtain a copy of the show report from the show secretary the day of the show.

Motion failed to abolish Article 7, number 6. The vote was 3 for, 6 against, and 3 abstained.

Motion from District 1 was withdrawn. It was meant for the club not ABS.

Motion was determined to already be addressed in the judge's Panel Handbook that there is a procedure for a judge to return after a suspension.

Motion failed that ABS should approach BAA with a request for them to merge clubs. (Vote 2 for, 9 against, 2 abstained) ABS is open to discussions for the betterment of the hobby.

Motion from the general meeting passed that any ABS officer that abandons any position in ABS for non-hardship reason should be restricted from running for another position for four calendar years from the time of abandonment. (Vote 7 for, 2 against, 4 abstained)

Motion passed that Judges should not be recorded or live streamed on social media without the judge's permission.
